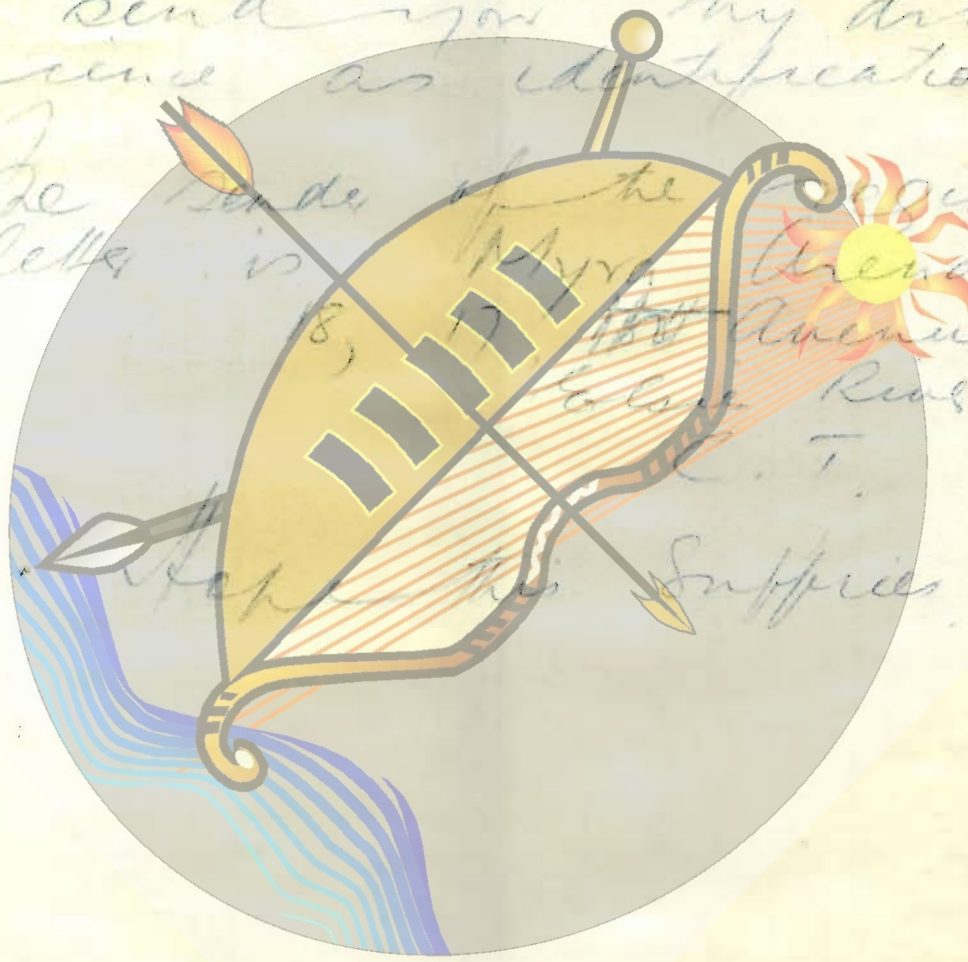

Your letter dated 12th August, 1969 in reply to mine of the 18th July, 1969 reached me on the 13th August, 1969, for which I thank you.

While same is explanatory of the rental of the rental debit on the June account for period 1st July to 30th September 1969, I am afraid you do not explain why a rental of R4.50 was charged for May and June when your department took over from the Durban Corporation.

You will recall that under the Municipality rentals were charged per month at the rate of R1.50. Therefore rental for April was paid. As I see it rental for that period should have been in the sum of R3.00. For by your calculation it is not a quarter the period May and June.

I would like an explanation of the above. Also this service was discontinued on the 31st July.

I enclose my account in the sum of R9.52 for your attention and reply in all the above circumstances.
