ANNUAL REPORT 1979

The General Committee has pleasure in submitting the following report on the Society's activities during 1979:

1. During the year 730 new members were enrolled and 209 existing members increased their benefits to the maximum of R1 000.
2. The contribution income increased by R29 700 from R262 781 to R292 481 and the interest income by R32 205 from R325 922 to R358 127.
3. Although interest rates on investments continued to decline during the year, the Society was nevertheless able to invest all available funds at an average interest rate of 10,65%. The average rate of interest on total investments at present amounts to 8,48%.
4. The Society's management expenses amounted to R61 634 which represents 9,5% of the total contribution and interest income.
5. The enrolment of new members is of vital importance for the growth of the Society. In view of the fact that all departments, especially those outside Pretoria, cannot be visited regularly by the Society's staff, members and Personnel Officers are kindly requested to propagate the benefits of the Society. In order to stimulate the recruiting of new members an honorarium of R0,50 for every R200 insurance taken out by a member will be paid to the canvasser.
6. The amendment of the following rules was approved during the special general meeting held on 26 April 1979 and came into operation on 14 May 1979:
 1. Rule 3: Substitute the words "705 Northvaal Building, 227 Vermeulen Street", by the words "123 Centenary Building, Bureau Lane".
 2. Rule 11: Substitute in paragraph (i) the amount "R40", by the expression "R20 per unit of R200".
 3. Rule 16: Substitute in paragraph (ix) the words "in each month" by the words "in every three months".
 4. Rule 33: Substitute rule 33 by the following new rule:

"33(i) Notwithstanding anything to the contrary in these rules the General Committee shall be entitled to amend the rules; provided that —

 - (a) No alteration, rescission or addition which affects the objects of the Society, or which increases the rates of contribution by more than fifteen percent or decreases the extent of any benefit, shall be valid unless it has been approved by a majority of members present at a general meeting or a special general meeting;
 - (b) any alteration, rescission or addition which affects the rates of contribution or extent of any benefit shall be supported by a recommendation of the Society's actuary; and
 - (c) no alteration, rescission or addition shall be valid unless it has been approved and registered by the Registrar in terms of the Act.

(ii) Members shall be furnished with a copy of the amendments as soon as possible after registration thereof."
 5. Rule 37: Substitute paragraph (i) by the following paragraph:

"(i) Recruiting fees, not exceeding three months' contributions, may be paid to a recruiting officer only after the Society has received three months' contributions from the member."
7. Personnel Officers and other officials of departments, especially those who assisted with the canvassing of new members, as well as members of the General Committee and the staff of the Society, are sincerely thanked for their assistance and co-operation.

JAARVERSLAG 1979

Die Hoofbestuur bied met genoë die volgende verslag in verband met die Vereniging se werksaamhede vir 1979 aan:

1. Gedurende die jaar is 730 nuwe lede ingeskryf terwyl 209 bestaande lede hul voordele verhoog het tot die maksimum van R1 000.
2. Die bydrae-inkomste het met R29 700 gestyg van R262 791 tot R292 481 en die rente-inkomste met R32 205 van R325 922 tot R358 127.
3. Hoewel rentekoerse op beleggings steeds gedurende die jaar gedaal het, was die Vereniging nogtans in staat om alle beskikbare fondse teen 'n gemiddelde rentekoers van 10,65% te belê. Die gemiddelde rentekoers op die totale beleggings is tans 8,48%.
4. Die Vereniging se bestuurskoste het R61 634 beloop wat 9,5% van die totale bydrae- en rente-inkomste verteenwoordig.
5. Die inskrywing van nuwe lede is van lewensbelang vir die groei van die Vereniging. Aangesien alle departemente, veral dié buite Pretoria, nie gereeld deur die Vereniging se personeel besoek kan word nie, word lede en personeelbeampes vriendelik versoek om die voordele van die Vereniging te propageer. Ten einde die werwing van lede te stimuleer word 'n honorarium van R0,50 vir elke R200 versekering wat deur 'n lid uitgeneem word, aan die werwer betaal.
6. Die wysiging van die volgende reëls is tydens die buitengewone algemene vergadering van lede, gehou op 26 April 1979, goedgekeur en het op 14 Mei 1979 in werking getree:
 1. Reël 3: Vervang die woorde "Noordvaalgebou 705, Vermeulenstraat 227", deur die woorde "Centenarygebou 123, Bureausteeg".
 2. Reël 11: Vervang in paragraaf (i) die bedrag "R40", deur die uitdrukking "R20 per eenheid van R200".
 3. Reël 16: Vervang in paragraaf (ix) die woorde "gedurende elke maand" deur die woorde "gedurende elke drie maande".
 4. Reël 33: Vervang reël 33 deur die volgende nuwe reël:

"33(i) Ondanks andersluidende bepalinge in hierdie reëls sal die Hoofbestuur die reg hê om die reëls te wysig, met dien verstande dat —

 - (a) Geen wysiging of herroeping of byvoeging wat die doelstellings van die Vereniging raak of wat die tariewe van bydrae met meer as vyftien persent verhoog of wat die bedrag van enige voordeel verminder, sal van krag wees nie tensy dit deur 'n meerderheid van lede teenwoordig op 'n algemene vergadering of buitengewone algemene vergadering goedgekeur is;
 - (b) enige wysiging, herroeping of byvoeging wat die tariewe van bydrae of die bedrag van die voordele raak, moet deur 'n aanbeveling van die Vereniging se aktuaris gesteun word; en
 - (c) geen wysiging, herroeping of byvoeging sal van krag wees nie tensy dit deur die Registrateur kragtens die Wet goedgekeur en geregistreer is.

(ii) Lede moet van 'n afskrif van die wysigings voorsien word so gou moontlik nadat dit geregistreer is".
5. Reël 37: Vervang Paragraaf (ii) deur die volgende paragraaf:

"(ii) Werwingsgeld, wat nie drie maande se bydraes mag oorskry nie, kan aan 'n werwingsbeaampte uitbetaal word slegs nadat die Vereniging drie maande se bydraes van die lid ontvang het."
7. Personeel- en ander beampes van departemente, veral dié wat gehelp het met die werwing van nuwe lede, asook lede van die Hoofbestuur en die personeel van die Vereniging, word hartlik bedank vir hul hulp en samewerking.
