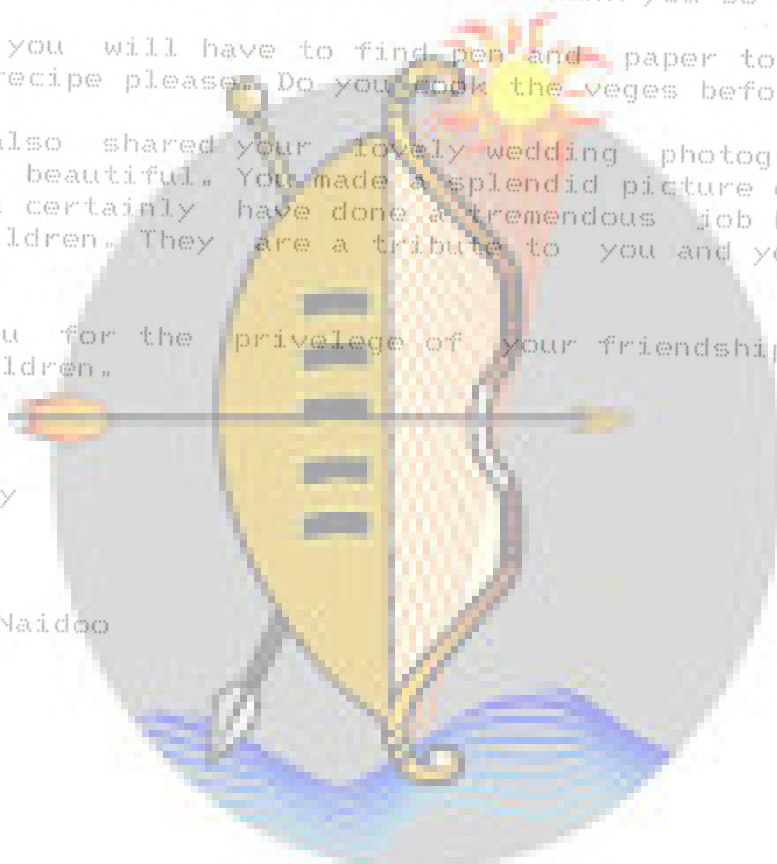
I think you will have to find pen and paper to give me a copy of the recipe please. Do you cook the veges before pickling.

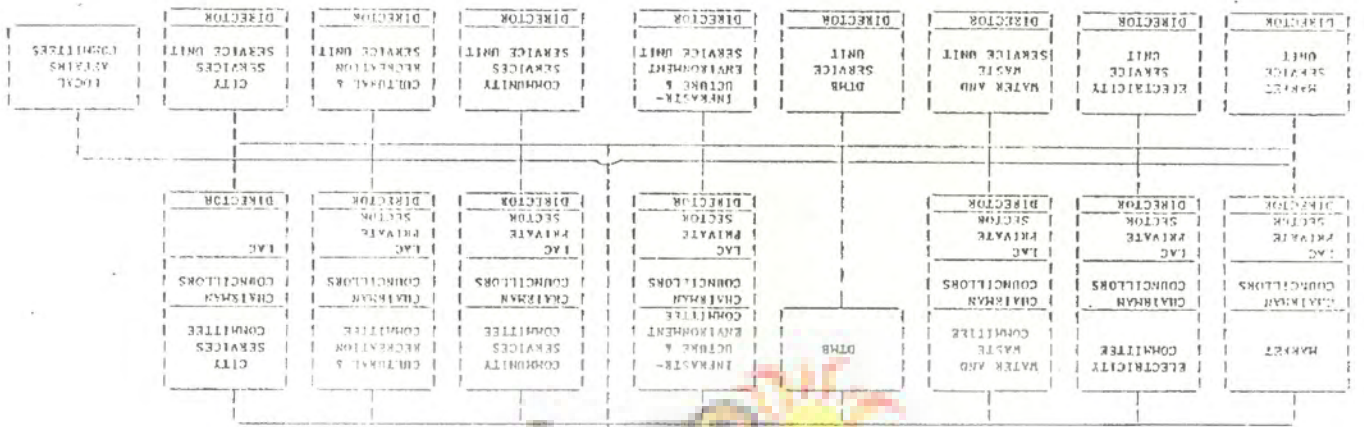

Thank you for the privilege of your friendship and some of your children.

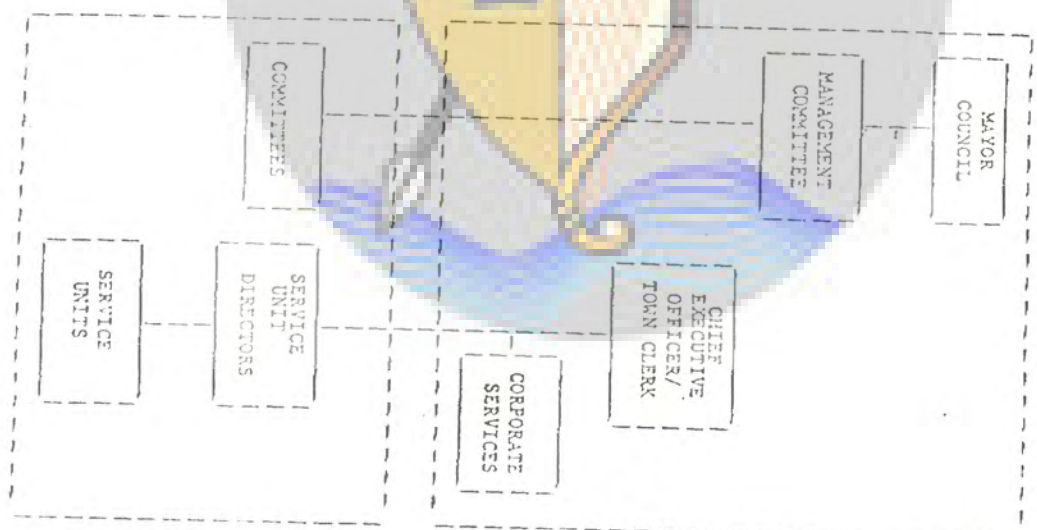
