It is Diwali to you a practising, Telegu speaking hindu, it has more significance. To me with my Christian upbringing it is a noisy holiday. I sit here this Sunday alone, for at your instance my children have gone to Somebody's home, till Tuesday.

Sukhthi This week has been a repeat of last week. You after phoning me - does not know my number - get her to say to me - "I don't feel like coming with you tonight Mummy" What happiness this must bring you. DID HE WHO MAKE THE LAMB MAKE THEE!

I have seen her in all twice in two weeks. You have violated the agreement made in the presence of my brothers and Jay, whereby I was to have Sukhthi and you the boys. Of course you so arrogantly say to Omar that agreement has been overridden. You should add -by yourself of course.

I don't wonder that people call you COMMISSAR. You are that in all its evil connotations. Your injured ego, propped up by five years in jail in the cause of freedom (freedom from ~~what~~ ^{what} gives you the halo of self righteousness you wear. You ~~are~~ ^{seem to be} determined to meet out punishment for the way you ~~have been wronged~~. **EVEN USE MY CHILDREN TO DO IT.**

You feel very pleased when the children refuse to come to me. You so smugly tell people I am not stopping them...they don't want to go. Do you tell them how they fear you. They obey you out of fear. Do you tell that that Sukhthi won't sleep with you unless accompanied by Sahdhan. That Sha, though you plead with him has never slept with you. You might be warned that if I sue you, Counsel has already indicated throwing your testamoney in your trial against you. I dont want to do that. But if you dont afford my children some certainty and security there shall be no limits to the exent I will travel to see some justice done.
